Description: A ladies stamped 18k rose gold four tanzanite and six diamond pendant. The tanzanite and diamonds are rub over bezel set in a vertical cluster design. The pendant contains a double hidden bale, measures 26mm x 14mm and is of cad cast manufacture.

- 1 x Tanzanite – pear faceted, 9.40mm x 6.2mm x 4.00mm, estimated weight 1.34ct, medium-light violet blue colour.
- 1 x Tanzanite – trilliant faceted, 5.60mm x 5.80mm x 3.70mm, estimated weight 0.66ct, strong violet blue colour.
- 1 x Tanzanite – marquise faceted, 9.50mm x 4.80mm x 2.70mm estimated weight 0.65ct, medium violet blue colour.
- 1 x Tanzanite – round faceted, 5.40mm x 5.40mm x 3.20mm, estimated weight 0.55ct, light grey-blue colour.
- 2 x Diamonds – round brilliant cut, 4.30mm x 4.35mm, estimated weight 0.28ct each, Colour Treated Black.
- 1 x Diamond – round brilliant cut, 3.9mm x 3.9mm x 2.5mm, estimated weight 0.23ct, Colour Treated Black.
- 2 x Diamonds – round brilliant cut, 2.4mm, estimated weight 0.05ct each, Colour Treated Black.
- 1 x Diamond – round brilliant cut, 2.0mm, estimated weight 0.03ct, Colour Treated Black.

Due to the stones being set the weight, clarity and colour are estimated.
