1 x Tanzanite – rectangular cushion faceted, 7.10mm x 5.35mm x 3.10mm, estimated weight 1.08ct, medium violet blue colour, Clarity: eye clean.

1 x Diamond – round brilliant cut, 3.8mm x 3.8mm x 2.4mm estimated weight 0.21ct, Colour: Treated black.

1 x Diamond – round brilliant cut, 3.6mm x 3.6mm x 3.0mm estimated weight 0.23ct, Colour: Treated black.

2 x Diamonds – round brilliant cut, 3.0mm, estimated weight 0.10ct, Colour: Treated black.

1 x Diamond – round brilliant cut, 2.6mm, estimated weight 0.07ct, Colour: Treated black.
