Description: A 9ct, stamped 375 JP02 yellow gold seventy seven diamond ring. The central diamond is rhodium plate eight claw set with two surrounding halos of rhodium plate four claw set diamonds. Diamonds are channel set in the central row with diamonds rhodium plate four claw set along the outer rows, set in the flared shoulders. The slightly rounded flared band measures 3.0mm at the base. Cast manufacture. Ring Size: O.

- 20 x Diamonds – tapered baguette cut, 1.6mm to 2.3mm in length, estimated averaged weight 0.015ct each, Clarity SI, Colour J-L.
- 24 x Diamonds – single cut, 1.1mm to 1.2mm, estimated weight 0.005ct each, Clarity SI, Colour K-M.

Due to the stones being set the weight, clarity and colour are estimated.
