The princess cut diamond is rub over square bezel set in the centre. Round brilliant cut diamonds are micro-claw set in rows of three in four individual sections of the square frame. Micro-claw set diamonds are displayed in graduated rows upon each tapered shoulder. The flat lower shank measures 1.78mm wide at the base and 2.68mm wide at the shoulders. This item is of mass production cast manufacture. Size M 1/2. 4.14 grams.
