Item 1

One hand finished, 18ct white gold & diamond set, dress ring. Plain, wide, low half round, parallel band, measures 6.92mm width x 2.39mm depth, with cut-out underrail, open back setting, underneath.

Feature, "dress style" wide band. Comprising, a rub-over setting to top, double grooved line each side, the entire circumference of the outer band. Railed inside the entire circumference of the band.

Polished & satin/brush finish, stamped "(c) Tiffany & Co 750, Lucinda (R) Pat 5970744 Ct Ap. - acid tested as 18 carat gold.

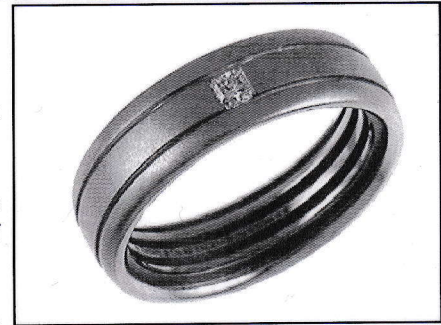
Finger size = S1/2.

The ring contains;

One rub-over set Lucida cut, faceted diamond, clarity is "Vs", colour is "G", medium cut quality.
Dimensions = 2.80mm (L) x 2.80mm (W) x 1.93mm (D-estimated)
Total Weight = 0.12ct (estimated - see NOTE below).

Total Item Weight = 9.21 grams, Total Gemstone Weight = 0.12ct, Total Metal Weight = 9.19 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the Lucida cut diamond, cannot be ascertained. Therefore, weights of the Lucida cut diamond, are very much estimated. For accurate testing, weights, colour, and clarity gradings, the Lucida cut diamond, require removal from the setting. The ring has a stamp of Tiffany & Co upon - however, Tiffany in Melbourne will not assist with help in authenticating whether or not the ring is of their supply. Therefore, the below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
