Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 10ct white gold & gemstone set, cluster ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.28mm width (at base) x 1.30mm depth, with curved, open back settings, underneath.

Feature, "cluster style" ring design. Comprising, a raised four claw setting, to top, houses one oval-shaped, faceted, topaz, claw set. Drops to a double surround, containing, sixty eight single cut diamonds, bead set. The extended shoulders, of the band, tapers up wide to the top, from both sides.



Polished finish, stamped "10K, MHJ" - acid tested approximately 10 carat gold. Finger size = J1/2.

The ring contains;

One claw set oval shaped, faceted, topaz, colour is "medium - blue".

Dimensions = 10.16mm (L) x 8.04mm (W) x 4.90mm (D-estimated)

Total Weight = 2.87ct (estimated - see NOTE below).

Sixty Eight bead set single cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 1.00mm (average diameter)

Total Weight = 0.34ct (estimated - see NOTE below).

Total Item Weight = 5.73 grams, Total Gemstone Weight = 3.21ct, Total Metal Weight = 5.09 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
