Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 9ct white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.75mm width (at base) x 0.94mm depth, with cut-out underrail, open back settings, underneath.

Feature, "cluster style" ring design. Comprising a raised cluster setting to top, houses one round brilliant cut diamond to centre, drops to a basket surround, contains ten round brilliant cut diamonds, all claw set. The extended shoulders, of the band, tapers up to pointed end terminations to both sides.



Polished finish, stamped "9K EX" - acid tested as 9 carat gold. Finger size = K1/2.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.

Dimensions = 3.08mm (Diameter) x 1.88mm (D-estimated)

Total Weight = 0.11ct (estimated - see NOTE below).

Ten claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H", medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated)

Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight = 1.69 grams, Total Gemstone Weight = 0.21ct, Total Metal Weight = 1.65 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
