Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised, 14ct white gold & gemstone set, dress ring. Plain, narrow, flat, low half round, tapered band, measures 2.66mm width (at base) x 0.90mm depth, with split underrail.

Feature, "dress style" ring design. Comprising, a raised cup setting to centre houses one round cultured black pearl, end drilled glue set. The extended shoulders, shoulder of the band, tapers up to the top, splits to each side.

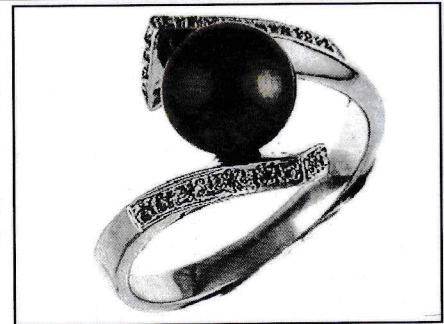
Polished finish, stamped "14K" - acid tested as 14 carat gold.

Finger size = O.

The ring contains;

One end-drilled round cultured dark bronze pearl, lustre is "Medium", blemish is "Very few blemishes".
Dimensions = 8.10mm (Diameter)
(estimated - see NOTE below).

Twenty Four claw set round cubic zirconias, colour is "colourless".
Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated)
Total Weight = 0.12ct (estimated - see NOTE below).



Total Item Weight = 4.35 grams, Total Gemstone Weight = 0.12ct, Total Metal Weight = 3.57 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
