### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 10ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, wide, low half round, tapered band of 4.14mm width (at base) x 1.11mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature rectangle top plate, housing four rows of seven round brilliant cut diamonds, slightly graduating in size, largest to the centre, and channel set. The top plate is secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '417 MHJ' - acid tested as 9 carat gold.

Ring size: U.

The ring contains:

Twenty Eight channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed).  
Dimensions = 1.95mm(Dia) x 1.19mm(D-estimated) x 2%(Girdle Thickness) (smallest)  
Dimensions = 2.22mm(Dia) x 1.35mm(D-estimated) x 2%(Girdle Thickness) (largest)  
Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 7.65 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 7.45 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
