

## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled raised, 10ct white gold & gemset, flexible link bracelet.

Feature' single line style" bracelet. Comprising, fifty seven individual raied four claw settings, hinged, run the entire length of the bracelet, each contain one round brilliant cut diamond, illusion claw set, open back underneath. The bracelet having a box style clasp features three raised illusion claw setting to top, contains three round brilliant cut diamond. Attached to each side of the clasp, is a figure 8 safety clip.



Polished finish, stamped "10K, 1.00, MHJ" - acid tested approximately 10 carat gold.

Bracelet dimensions = 19.00cm (total length) x 3.03mm (width) x 3.29mm (depth).

The bracelet contains:

Sixty One illusion claw set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality. Dimensions = 1.55mm (average diameter) x 0.95mm (D-estimated) Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 12.19 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 11.99 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar single line style bracelet, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
