Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, multi-stone, ring set, of cast construction.

The set comprising a 18ct white gold diamond set engagement ring with a matching 18ct white gold diamond set wedding ring. Each ring having a plain, narrow, low half round, tapered band with a combined basal width of 6.54mm x 1.28mm in depth.

The engagement ring has a central four claw setting, housing one Princess cut diamond, claw set. The setting is secured between the shoulders of the plain and polished band. Each of the extended and square shoulders houses one row of five Princess cut diamonds, channel set. The matching wedding ring, has one row of twelve Princess cut diamonds, spanning across the top of the band, channel set. The settings are secured between the shoulders of the plain and polished band. The wedding ring sits alongside the engagement ring above.



Polished finish. Stamped '750' - acid tested as 18 carat gold. Ring size: L.

The ring set contains:

One claw set Princess cut diamond, clarity is "Vs2", colour is "D".

Dimensions = 5.07mm(L) x 4.98mm(W) x 3.48mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.72ct (known weight - see NOTE below)

Twenty Two channel set Princess cut diamonds, clarity is "Vs", colour is "G to H" (mixed).

Dimensions = 1.90mm(L) x 1.90mm(W) x 1.35mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.03ct (estimated - see NOTE below)

Total Item Weight = 8.54 grams Total Gemstone Weight = 1.75ct Total Metal Weight = 8.19 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 2111696912 Dated: Feb. 18, 2010. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2111696912. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
