Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct white gold & gemset, multistone ring. Plain, wide, low half round, tapered band, measures 3.66mm width (at base) x 1.48mm depth, with curved underrail.

Feature, "dress style" design. Comprising, two flower clusters housing eight oval-shaped, faceted, natural sapphires, claw set. The extended shoulders, of the band, tapers up, splits into three rails, plain to centre, diamond set each side, contains a total of thirty five round brilliant cut diamonds, claw set, both sides.

Polished finish, stamped "18k, 750, 2.01 0.25" - acid tested as 18 carat gold.

Finger size = M.

The ring contains;

Eight claw set oval-shaped, faceted, natural sapphires, colour is "medium dark blue".

Average dimensions = 4.00mm (L) x 3.08mm (W) x 2.40mm (D-estimated)

Total Weight = 2.00ct (estimated - see NOTE below).

Thirty Five claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.09mm (average diameter) x 0.66mm (D-estimated) (smallest)

Dimensions = 1.28mm (average diameter) x 0.78mm (D-estimated) (largest)

Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 5.40 grams, Total Gemstone Weight = 2.25ct, Total Metal Weight = 4.95 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
