## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, gem set, flexible link bracelet, of hand-assembled construction.

Feature one row of articulated railed four claw settings, each housing one round brilliant cut diamond, claw set. There are a total of seventy-seven round brilliant cut diamonds. The bracelet is finished with a box clasp, and two figure 8 safety catches.

Bracelet dimensions = 18.00cm (ave. length) x 2.22mm (ave. width) x 2.32mm (ave. depth).

Polished finish.

Stamped 'ROSENDORFF 750 D2.03ct' - acid tested as 18 carat gold.

The bracelet contains:

Seventy Seven claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to I" (mixed). Dimensions (average) = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 2.03ct (estimated - see NOTE below)

Total Item Weight = 6.99 grams Total Gemstone Weight = 2.03ct Total Metal Weight = 6.59 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bracelet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
