Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow gold drop style, cultured pearl & diamond pendant.

Feature, 'drop style' pendant. Comprising, a fluted v-shaped bail to top, housing two round brilliant cut diamond, bead set. Drops to an articulated yellow gold cap with a teardrop shaped South Sea cultured pearl drop, drilled & glue set.

Polished finish, stamped "750, P" - acid tested as 18 carat gold.

Pendant dimensions = 22.00mm (total length) x 5.28mm (width) x 5.80mm (depth).

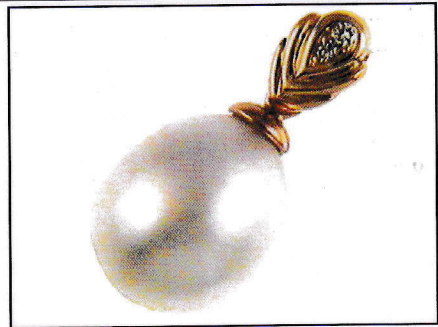
The pendant contains:

One end-drilled teardrop South Sea cultured white/pink pearl, lustre is "Medium", blemish is "Few blemishes".
Dimensions = 13.47mm (L) x 10.88mm (W) x 10.88mm (D)

Two bead set round brilliant cut diamonds, clarity is "Si", colour is "I to J"(mixed), medium cut quality.
Dimensions = 1.18mm (average diameter) x 0.72mm (D-estimated) (smallest)
Dimensions = 1.64mm (average diameter) x 1.00mm (D-estimated) (largest)
Total Weight = 0.02ct (estimated - see NOTE below).

Total Item Weight = 3.43 grams, Total Gemstone Weight = 0.02ct, Total Metal Weight = 0.68 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
