## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 10ct white gold and 14ct white gold, gem set, flexible link necklet, of hand-assembled construction.

Feature 'cross' style pendant, housing a total of sixteen laboratory synthetic diamonds, varying in size, claw set. The pendant has an articulated tapered bail. The pendant is suspended on a 'box 'style chain, that has been finished with a small bolt ring.

Chain dimensions = 50.50cm (ave. length) x 1.08mm (ave. width).

Pendant dimensions = 32.00mm (wve. length) x 19.00mm (ave. width) x 3.10mm (ave. depth).

Polished finish.

Stamped 'K10 LG(pendant) 585 K14 JAPAN' - acid tested as 10 carat gold and 14 carat gold.

The necklet contains:

Sixteen claw set round brilliant cut laboratory synthetic diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed). Dimensions = 2.34mm(Dia) x 1.43mm(D-estimated) x 2%(Girdle Thickness) (smallest) Dimensions = 2.69mm(Dia) x 1.64mm(D-estimated) x 2%(Girdle Thickness) (largest) Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 5.98 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 5.78 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the laboratory synthetic diamonds cannot be ascertained. Therefore, weights of the laboratory synthetic diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the laboratory synthetic diamonds require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
