Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand crafted raised, 18ct yellow and white gold, gemstone set (mixed), three stone ring.

Plain, narrow, low half round, tapered band, measures 2.65mm width (at base) x 1.34mm depth, with open back, settings underneath.

Feature, "trilogy style" ring design. Comprising, a white gold capped trilogy setting, housing one round, faceted, rhodolite type garnet, rub-over set. Flanked each side, one round brilliant cut diamond, bead set. The extended shoulders, of the yellow gold band tapers up wide to the top, from both sides.

Polished finish, unstamped - acid tested as 18 carat gold. Finger size = N1/2.

The ring contains;

One rub-over set round rhodolite type garnet, colour is "medium dark, reddish purple".
Dimensions = 6.08mm (Diameter) x 4.39mm (D-estimated)
Total Weight = 1.12ct (estimated - see NOTE below).

Two bead set round brilliant cut diamonds, clarity is "Si", colour is "G", medium cut quality.
Dimensions = 3.29mm (average diameter) x 2.01mm (D-estimated)
Total Weight = 0.27ct (estimated - see NOTE below).

Total Item Weight = 6.90 grams, Total Gemstone Weight = 1.39ct, Total Metal Weight = 6.62 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
