## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 9ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 7.45mm at top to 2.30mm in width (at base) x 0.89mm depth, with hollow top and shoulders, and open back settings.

Feature domed top consisting of a five row design, housing a total of forty-four round brilliant cut diamonds, tapering in size, pave' set. Rhodium plating to the setting areas.

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Finger size is T.

The ring contains:

Forty Four pave' set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'brown tint'.

Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.45mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.17 grams Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.07 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
