## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, hand finished, raised 18ct yellow gold & diamond set, three stone ring. Plain, narrow, low half round, tapered band, measures 1.58mm width (at base) x 0.74mm depth, with split underrail.

Feature; "trilogy style" design. Comprising, 2 x four claw setting to one side & 1 x four claw setting to centre of split ontop. The extended shoulders, of the band tapers up, to split one side the other to the centre of split in cross over trilogy design.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = 0.

The ring contains;

Three claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.05mm (average diameter) x 1.25mm (D-estimated) (smallest)

Dimensions = 2.16mm (average diameter) x 1.32mm (D-estimated) (largest)

Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight = 2.27 grams, Total Gemstone Weight = 0.10ct, Total Metal Weight = 2.25 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
