Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of hand-assembled, 18ct yellow gold, diamond set earrings.

Feature 'drop' style earring design, each consisting of one open back bezel setting, rub-over set with one round brilliant cut diamond. Articulated from the base, is a hollow and open back, 'square-shape' setting, invisible set with nine Princess cut diamonds.

Threaded post and butterfly fittings attached.

Polished finish - stamped '18K' (on butterflies) - acid tested as 18 carat gold.

Earring dimensions = 14.92mm (ave. length) x 3.44mm to 11.16mm (ave. width).

The earrings contain:

Two rub over set round brilliant cut diamonds, clarity 'P1', colour 'H & brown tint' (mixed).
Dimensions = 2.65mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.14ct (estimated - see NOTE below)

Eighteen invisible set Princess cut diamonds, clarity 'P1 & P2' (mixed), colour 'G to H' (mixed).
Dimensions (average) = 2.20mm(L) x 2.20mm(W) x 1.40mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.86ct (estimated - see NOTE below)

Total Item Weight = 4.56 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 4.36 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
