Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 12.84mm at top to 4.54mm in width (at base) x 1.25mm depth, with a curved and pierced 'honeycomb' style underrail.

Feature four row ring design, housing a total of twenty-eight round brilliant cut diamonds, channel set. Rhodium plating inside the setting areas.

Polished finish.

Stamped '9ct JP146' - acid tested as 9 carat gold.

Finger size is V.

The ring contains:

Twenty Eight channel set round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'H to J' (mixed).
Dimensions (average) = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.80ct (estimated - see NOTE below)

Total Item Weight = 7.87 grams

Total Gemstone Weight = 0.80ct

Total Metal Weight = 7.71 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
