Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's raised, 14ct white gold & "laboratory grown synthetic" diamond set ring. Of cast construction.

Plain, narrow, low half round, tapered band, measures, 2.15mm width (at base) x 1.54mm depth with underrail.

Feature, 'solitaire style" design. Comprising, a four claw setting to top, houses one round modified brilliant cut "laboratory grown synthetic" diamond, (laser inscribed michael hill, 71015110), claw set. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "14K michael hill 71015110" - acid tested as 14 carat gold.

Finger size = O1/2.

The ring contains;

One claw set round modified brilliant cut, "laboratory grown synthetic" diamond, clarity is "Vs2", colour is "I", medium cut quality.
Dimensions = 4.54mm (average diameter) x 2.60mm (D-estimated) x 3%(Girdle Thickness)
Total Weight = 0.33ct (estimated - see NOTE below).



Total Item Weight = 2.24 grams, Total Gemstone Weight = 0.33ct, Total Metal Weight = 2.17 grams (estimated)

NOTE: Limited gemmological testing, inset. No certification presented at the time of the valuation. Inset tests, indicate The stone to be a round modified brilliant cut "laboratory grown synthetic diamond" & is laser inscribed on the girdle "michael hill 71015110". Due to setting constraints, the exact dimensions of the "laboratory grown synthetic diamond" cannot be ascertained. Therefore, weight of the "laboratory grown synthetic diamond" are very much estimated. For accurate testing, weights, colour, and clarity gradings, the "laboratory grown synthetic diamond" would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
