Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand crafted, 18ct white gold, cluster style, gem set, dress ring.

Plain, narrow, tapered band of 2.48mm in width (at base) x 1.09mm depth, with open back setting.

Feature central four claw setting, housing one oval cut and faceted natural sapphire, claw set. Surrounded by twelve single cut diamonds, bead set. The setting base of a pierced 'basket' style. Secured between the shoulders of the plain and polished band. Each shoulder having a four claw setting, housing one single cut diamond, claw set.



Polished finish - stamped '18CT PALL' - acid tested as 18 carat gold. Finger size is M 1/2.

The ring contains:

One claw set mixed cut oval shape natural sapphire, colour 'very dark blue'.

Dimensions = 6.31mm(L) x 5.20mm(W) x 3.26mm(D-estimated)

Total Weight = 0.90ct (estimated - see NOTE below)

Fourteen bead set & claw set (mixed) single cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).

Dimensions = 1.60mm (ave. diameter)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 4.30 grams - Total Gemstone Weight = 1.14ct - Total Metal Weight = 4.07 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
