Valuation for Traditional Retail Insurance Replacement

One, 18ct white gold, three diamond ring, of cast construction.

Plain, narrow, tapered band of 1.78mm in width (at base) x 1.19mm depth, with open back settings.

Feature three individual, four claw railed settings, each housing one round brilliant cut diamonds, largest to the curved centre, all claw set. Secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '18K 0.33' - acid tested as 18 carat gold.

Finger size is N.

The ring contains:

Three claw set round brilliant cut diamonds, clarity 'P1', colour 'G'.

Dimensions = 2.90mm(Dia) x 1.77mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.20mm(Dia) x 1.95mm(D-estimated) x 2%(Girdle Thickness) (largest)
