Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round band of 2.89m width (at base) x 1.26mm depth, with open back settings.

Feature one row of seventeen round brilliant cut diamonds, spanning around almost the entire circumference of the band, varying in size and claw set. The settings are secured between the plain and polished band.

Polished finish.

Stamped '18K 750' - acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

- Seventeen claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).
Dimensions = 2.45mm(Dia) x 1.49mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 3.28 grams
Total Gemstone Weight = 1.00ct
Total Metal Weight = 3.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
