Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'dress' style ring, of hand-assembled construction.

Plain, wide, flat band of 5.78mm width (at base) x 1.32mm depth.

Feature central four claw setting, housing one rectangle natural blue topaz, claw set. The band has an open 'scroll' design, embellished with five round synthetic cubic zirconias, varying in size, and eleven single cut diamonds, also varying in size, all bezel set. The design is framed with two thin bands, to the top and bottom, that run the entire circumference of the band.



Polished finish. Unstamped - acid tested as 18 carat gold. Ring size: O.

The ring contains:

One claw set rectangular natural topaz, colour is "blue".

Dimensions = 11.72mm(L) x 9.94mm(W) x 5.64mm(D-estimated)

Total Weight = 6.03ct (estimated - see NOTE below)

Five bezel set round synthetic cubic zirconias, colour is "colourless".

Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) (smallest)

Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) (largest)

Total Weight = 0.07ct (estimated - see NOTE below)

Eleven bezel set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 0.90mm(diameter) (smallest)

Dimensions = 1.40mm(diameter) (largest)

Total Weight = 0.09ct (estimated - see NOTE below)

Total Item Weight = 8.55 grams Total Gemstone Weight = 6.19ct Total Metal Weight = 7.31 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
