## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.26mm width (at base) x 0.84mm depth, with an open back setting.

Feature central white gold bezel setting, housing one pear shaped diamond, bezel set. The setting is secured between the shoulders of the plain and polished yellow gold band. The shoulders are embellished with white gold 'strap' style detail.

Polished finish.

Unstamped - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

- One bezel set pear shaped diamond, clarity is "P2", colour is "I".  
Dimensions = 7.63mm(L) x 5.14mm(W) x 3.09mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.74ct (estimated - see NOTE below)

Total Item Weight = 4.49 grams

Total Gemstone Weight = 0.74ct

Total Metal Weight = 4.34 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
