## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 1.17mm in width (at base) x 1.31mm depth, with a curved underrail.

Feature central two claw and one 'V' claw setting, consisting of an illusion plate, housing one round brilliant cut diamond, illusion set. Surrounded by sixteen round brilliant cut diamonds (smallest), claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having seven round brilliant cut diamonds, tapering in size, two smallest at the top, claw set.



Polished finish - stamped '375 JP02' - acid tested as 9 carat gold. Finger size is U.

The ring contains:

One illusion set round brilliant cut diamond, clarity 'P1', colour 'H'.

Dimensions = 3.95mm(Dia) x 2.41mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Thirty claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to J' (mixed).

Dimensions = 1.25mm(Dia) x 0.76mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 2.80 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 2.69 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
