Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold, articulated, gem set bracelet.

Feature articulated bracelet design, consisting of twelve two claw settings, each housing one marquise shape cabochon cut jadeite type material, claw set.

Press style, 'box' type clasp fitted, with one 'figure 8' safety catch fitted.

Polished finish.

Incorrectly stamped '22K' - x-rayed as between 17ct and 19.60ct gold.

Bracelet dimensions = 18.00cm (length) x 5.47mm (width).

The bracelet contains:

Twelve claw set marquise shape cabochon cut jadeite type material.
Dimensions (average) = 9.68mm(L) x 4.45mm(W)

Total Item Weight = 7.40 grams.

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bracelet employing similar materials and techniques being for a retail insurance purpose only.
