Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand crafted, 18ct yellow gold, dress style, gem set ring.

Plain, narrow, tapered band of 1.90mm in width (at base) x 0.54mm depth, with a curved underrail.

Feature 'U' shaped four claw setting, housing one emerald cut natural sapphire, claw set. Secured between the extended shoulders of the plain and polished band. Each shoulder having four single cut diamonds, star set.

Polished finish - stamped '18ct WB' - acid tested as 18 carat gold. Finger size is Q.

The ring contains:

One claw set emerald cut natural sapphire, colour 'dark green/blue'.
Dimensions = 6.87mm(L) x 5.70mm(W) x 4.10mm(D-estimated)
Total Weight = 1.63ct (estimated - see NOTE below)

Four star set single cut diamonds, clarity 'Vs', colour 'I to J' (mixed).
Dimensions = 1.60mm(ave. diameter)
Total Weight = 0.07ct (estimated - see NOTE below)

Total Item Weight = 4.79 grams - Total Gemstone Weight = 1.70ct - Total Metal Weight = 4.45 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The sapphire is heavily abraded to the crown. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
