Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.95mm width (at base) x 1.03mm depth, with open back settings.

Feature central raised six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the top of the plain and polished band. Each of the shoulders houses one row of three round brilliant cut diamonds, graduating in size, and channel set.

Polished finish.

Stamped '18K' - acid tested as 18 carat gold.

Ring size: I.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "G".

Dimensions = 4.86mm(L) x 4.85mm(W) x 3.00mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.43ct (estimated - see NOTE below)

Six channel set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 2.63mm(Dia) x 1.60mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.73mm(Dia) x 1.67mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.42ct (estimated - see NOTE below)

Total Item Weight = 4.04 grams Total Gemstone Weight = 0.85ct Total Metal Weight = 3.87 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
