Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of handmade construction.

Plain, narrow, low half round band of 1.66mm width (at base) x 1.08mm depth, with open back settings.

Feature assymetrical style cluster, with a central white gold four claw setting, housing one oval natural sapphire, claw set. To one side is five shared claw settings, each housing one round brilliant cut diamond, graduating in size, and claw set. The settings are secured to the extended and pointed shoulders, of the plain and polished yellow gold band.



Polished finish. Stamped '750' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

One claw set oval shaped natural sapphire, colour is "blue".

Dimensions = 7.12mm(L) x 5.09mm(W) x 3.10mm(D-estimated)

Total Weight = 1.00ct (estimated - see NOTE below)

Five claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G".

Dimensions = 2.51mm(Dia) x 1.53mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.19ct (estimated - see NOTE below)

Total Item Weight = 3.08 grams Total Gemstone Weight = 1.19ct Total Metal Weight = 2.84 grams (estimated)
