## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.34mm width (at base) x 1.22mm depth, with open back settings, with a curved underrail.

Feature round top plate, with a central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is one row of sixteen round brilliant cut diamonds, claw set. The top plate is secured to the extended and square shoulders, of the plain and polished band. Each of the shoulders houses one row of five Princess cut diamonds, channel set.



Polished finish. Stamped '750 W247 AC16' - acid tested as 18 carat gold. Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "J".

Dimensions = 4.88mm(Dia) x 2.98mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.44ct (estimated - see NOTE below)

Sixteen claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H".

Dimensions (average) = 1.22mm(Dia) x 0.74mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.13ct (estimated - see NOTE below)

Ten channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 4.22 grams Total Gemstone Weight = 0.97ct Total Metal Weight = 4.03 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
