## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, raised 9ct yellow gold & diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 1.32mm width (at base) x 0.69mm depth, with open back, underneath.

Feature "multi row style" ring design. Comprising, five channel set rows across the top of the band. Containing, twenty four round brilliant cut diamonds, tapering sizes. Alternates with forty baguette cut diamonds, all channel set. The extended shoulders, of the band, tapers up, splits, to the rows above, from both sides.

Polished finish, stamped "9K, JWBR, India" - acid tested as 9 carat gold. Finger size = N.

The ring contains;

Twenty Four channel set round brilliant cut diamonds, clarity is "P2 & P3"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 1.33mm (average diameter) x 0.81mm (D-estimated) (smallest)  
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)  
Total Weight = 0.30ct (estimated - see NOTE below).

Forty channel set baguette cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.  
Average dimensions = 1.24mm (L) x 1.04mm (W) x 0.76mm (D-estimated)  
Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 3.99 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.89 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
