Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct rose gold and 9ct white gold, diamond set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.50mm width (at base) x 1.11mm depth, with an open back setting and a curved underrail.

Feature central white gold illusion plate, housing one round brilliant cut diamond, illusion set. The illusion setting is within a six claw decorative setting, and is secured to the underrail and in between the tapering shoulders, of the plain and polished rose gold band.

Polished finish.

Stamped '9K' - acid tested as 9 carat gold.

Ring size: Q.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "P2", colour is "H".

Dimensions = 3.21mm(Dia) x 1.96mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 2.45 grams

Total Gemstone Weight = 0.12ct

Total Metal Weight = 2.43 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
