## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold, multistone, gem set ring, of cast construction. Plain, narrow, tapered band of 1.38mm in width (at base) x 0.85mm depth, with open back settings.

Feature central round brilliant cut diamond, secured between the 'wrap-around' style shoulders of the plain and polished band. The shoulders having a total of twenty-five tapered baguette cut diamonds, tapering in size, channel set.

Polished finish - stamped '18K 0.45' - acid tested as 18 carat gold. Finger size is S 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si', colour 'H'.

Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.07ct (estimated - see NOTE below)

Twenty Five channel set tapered baguette cut diamonds, clarity 'Vs & Si' (mixed), colour 'I to J' (mixed).

Dimensions = 1.30mm(L) x 1.00mm(W) x 0.50mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(L) x 1.30mm(W) x 0.75mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.38ct (estimated - see NOTE below)

Total Item Weight = 3.43 grams - Total Gemstone Weight = 0.45ct - Total Metal Weight = 3.34 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
