Item 1

One, 18ct white gold, 'solitaire' design, diamond set ring, of cast construction.

Plain, narrow, tapered band of 2.11mm in width (at base) x 1.09mm depth, with closed back settings.

Feature 'solitaire' style ring design, consisting of a four 'corner' claw railed setting, housing one Princess cut diamond, corner set. Secured between the extended shoulders of the plain and polished band.

Polished finish.

Stamped '18k michael hill 4588100103' - acid tested as 18 carat gold.

Finger size is L.

The ring contains:

One corner set Princess cut diamond, clarity 'P1', colour 'I'.

Dimensions = 5.14mm(L) x 4.97mm(W) x 3.64mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 3.89 grams

Total Gemstone Weight = 0.75ct

Total Metal Weight = 3.74 grams (estimated)



NOTE: The diamond has been laser inscribed upon the girdle with michael hill and 4588100103.
