Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.68mm in width (at base) x 1.23mm depth, with hollow top and shoulders, and open back settings.

Feature multi-row, 'cross-over' style ring design, housing thirty round brilliant cut diamonds, tapering in size, channel set in the two rows. Rhodium plating inside the rows.

Polished finish.

Stamped '375 JP02' - acid tested as 9 carat gold.

Finger size is V 1/2.

The ring contains:

- Thirty channel set round brilliant cut diamonds, clarity 'P1', colour 'H to I' (mixed).
- Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.45ct (estimated - see NOTE below)

Total Item Weight = 4.58 grams
Total Gemstone Weight = 0.45ct
Total Metal Weight = 4.49 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
