Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plan, narrow, low half round band of 2.02mm width (at base) x 1.37mm depth, with open back settings, and a curved underrail.

Feature oval top plate within a four claw setting, housing eleven round brilliant cut diamonds, largest to the centre, claw set. The setting is secured to the underrail, and in between the extended and square shoulders. Each of the shoulders houses one row of six round brilliant cut diamonds, in decorative settings, claw set.

Polished finish. Stamped '750 JP88' - acid tested as 18 carat gold. Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "I".

Dimensions = 4.50mm(Dia) x 2.75mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.34ct (estimated - see NOTE below)

Twenty Two claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "I to J" (mixed).

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.45mm(Dia) x 1.49mm(D-estimated) x 2%(Girdle Thickness)(largest)

Total Weight = 0.66ct (estimated - see NOTE below)

Total Item Weight = 4.30 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 4.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
