Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 2.01mm width (at base) x 0.83mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central raised four claw setting, housing one round brilliant cut diamond, claw set. Surrounding the central setting, is four 'ribbon' style panels, housing a total of twenty-six baguette cut and tapered baguette cut diamonds, graduating in size, and channel set. The settings are secured to the underrail, and in between the shoulders of the plain and polished band.



Polished finish. Stamped '750' - acid tested as 18 carat gold. Ring size: J.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "G".

Dimensions = 5.72mm(Dia) x 3.49mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.70ct (estimated - see NOTE below)

Twenty Six channel set tapered baguette cut and baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.41mm(L) x 0.84mm(W) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.26mm(L) x 1.38mm(W) x 1.01mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 3.27 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.06 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
