## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.39mm width (at base) x 1.13mm depth, with a curved underrail, and open back settings.

Feature central white gold decorative four claw setting, housing one Princess cut diamond, claw set. Either side of the central setting, is one three claw setting, each housing one round brilliant cut diamond, claw set. The settings are secured between the extended and pointed shoulders, of the plain and polished yellow gold band.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: R.

The ring contains:

One claw set Princess cut diamond, clarity is "SI1", colour is "I".

Dimensions = 3.67mm(L) x 3.64mm(W) x 2.58mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.35ct (estimated - see NOTE below)

Two claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.75mm(Dia) x 1.68mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 3.89 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 3.79 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
