Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of handmade construction.

Plain, narrow, low half round, tapered band of 0.87mm width (at base) x 1.08mm depth, with hollow top and shoulders, open back settings, and a curved underrail.

Feature 'vintage' style ring, with a central six claw setting, housing one round brilliant cut diamond, claw set. The setting is supported with a decorative gallery and engraved shoulder plates, with millegrain detail to the edge. Each of the shoulder plates houses two single cut diamonds, claw set. The settings are secured in between the shoulders of the plain and polished band.

Polished finish.

Unstamped - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

- One claw set round brilliant cut diamond, clarity is "Vs", colour is "I".
Dimensions = 3.97mm(L) x 3.96mm(W) x 2.42mm(D-estimated) x 1.5%(Girdle Thickness)
Total Weight = 0.20ct (estimated - see NOTE below)
- Four bead set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).
Dimensions (average) = 1.25mm (diameter)
Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 2.23 grams Total Gemstone Weight = 0.24ct Total Metal Weight = 2.18 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
