Valuation for Traditional Retail Insurance Replacement

One lady's, hand-assembled raised 10ct yellow gold & diamond set, flexible link bracelet.

Feature, "line style" bracelet. Comprising, a single row of articulated four claw setting, run the length of the bracelet, housing ninty four round brilliant cut diamonds, claw set. The bracelet having a tongue in box clasp closure, fitted with a figure eight safety clip.

Polished finish, stamped "10K MHJ 1.00 TDW" - acid tested approximately 10 carat gold.

Bracelet dimensions = 19.00cm (total length inclusive) $\times 1.91$ mm (width) $\times 2.48$ mm (depth).



The bracelet contains:

Ninety Four claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "I to J" (mixed), medium cut quality.

Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated) (smallest)

Dimensions = 1.39mm (average diameter) x 0.85mm (D-estimated) (largest)

Total Weight = 1.00ct (estimated - see NOTE below).

Total Item Weight = 5.97 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 5.78 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamondsare very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar style line bracelet, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
