Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold, diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.14mm width (at base) x 1.12mm depth with curved underrail.

Feature, "Trilogy style" ring design, with shoulder stones. Comprising, 3 x illusion six claw settings to top, centre, houses three round brilliant cut diamonds, illusion claw set in white gold. The extended shoulders, of the yellow gold band tapers up, each shoulder, topped with a white gold, mill grain edged extensions, containing three single cut diamonds, bead set, to both sides.

Polished finish, stamped "18ct, Pall" - acid tested as 18 carat gold.

Finger size = P.

The ring contains;

Three illusion claw set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 3.24mm (average diameter) x 1.98mm (D-estimated) (smallest)

Dimensions = 3.74mm (average diameter) x 2.28mm (D-estimated) (largest)

Total Weight = 0.52ct (estimated - see NOTE below).

Six bead set single cut diamonds, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 1.39mm (average diameter)

Total Weight = 0.08ct (estimated - see NOTE below).

Total Item Weight = 3.02 grams, Total Gemstone Weight = 0.60ct, Total Metal Weight = 2.90 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
