Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished raised, 10ct white gold & gemset, multistone ring, of cast construction.

Plain, wide, low half round, tapered band, measures 4.06mm width (at base) x 1.22mm depth, with curved underrail, cut out diamond shaped pattern underneath.

Feature, "raised brushed setting across the top of the band, housing nine round brilliant cut diamonds, channel set. The extended shoulders, of the plain band tapers up wide to the top, from both sides.

Polished finish, stamped "10K MHJ 0.50 TDW" - acid tested approximately 10 carat gold.

Finger size = Z.

The ring contains;

Nine channel set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.58mm (average diameter) x 1.50mm (D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below).

Total Item Weight = 7.58 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 7.48 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
