Valuation for Traditional Retail Insurance Replacement

Item 1

One gents, raised 18ct white gold & gemstone set, dress ring, of cast construction.

Plain, wide, low half round, tapered band, measures 4.74mm width (at base) x 1.23mm depth, with open back, setting underneath.

Feature, "dress style" ring. Comprising, a rectangular-shaped top, with cut out sides & a raised free formed rub-over setting to centre, houses one free form opal triplet, rub-over set. Two rows to each side top to bottom, contains nine round brilliant cut diamonds, bead set. The extended shoulders, of the band tapers up wide to the top, from both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = Z+3.

The ring contains;

One rub-over set opal triplet with rolling flash pattern, with blue, green play of colours.
Dimensions = 10.28mm (L) x 8.36mm (W) x 2.38mm (D-estimated)

Nine bead set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.
Dimensions = 1.15mm (average diameter) x 0.70mm (D-estimated)
Total Weight = 0.05ct (estimated - see NOTE below).

Total Item Weight = 15.10 grams.

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
