Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'three stone' style ring, of handmade construction.

Plain, narrow, high half round, tapered band of 2.15mm width (at base) x 1.96mm depth, with open back settings, and a curved underrail.

Feature 'vintage' style ring, with three white gold multi-shared claw settings, diagonally spanning across the top of the band. Each of the settings house one old cut diamond, slightly graduating in size, largest to the centre, and claw set. The settings are secured to the underrail, and in between the extended and pointed shoulders, in 'wrap around' style, of the plain and polished yellow gold band.

Polished finish.

Unstamped - acid tested as 18 carat gold.

Ring size: K.

The ring contains:

One claw set old cut diamond, clarity is "P2", colour is "yellow tint".

Dimensions = 4.18mm(L) x 3.87mm(W) x 2.36mm(D-estimated)

Total Weight = 0.31ct (estimated - see NOTE below)

Two claw set old cut diamonds, clarity is "P1 & P2" (mixed), colour is "light brown tint".

Dimensions = 3.90mm(L) x 3.88mm(W) x 2.37mm(D-estimated) (smallest)

Dimensions = 4.07mm(L) x 3.74mm(W) x 2.63mm(D-estimated) (largest)

Total Weight = 0.49ct (estimated - see NOTE below)

Total Item Weight = 3.03 grams Total Gemstone Weight = 0.80ct Total Metal Weight = 2.87 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
