Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.30mm width (at base) x 0.96mm depth, with a hollow top and shoulders, open back settings, and a curved underrail,

Feature central square top plate, housing four Princess cut diamonds, invisibly set. The top plate is secured to the underrail, and is framed by the extended and rounded shoulders. The shoulders lengthen out from the plain and polished band.



Polished finish.

Stamped '18CT 750' - acid tested as 18 carat gold.

Ring size: P.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Si & P1" (mixed), colour is "G to H" (mixed). Dimensions (avergae) = 2.50mm(L) x 2.50mm(W) x 1.77mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.36ct (estimated - see NOTE below)

Total Item Weight = 2.89 grams Total Gemstone Weight = 0.36ct Total Metal Weight = 2.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
