Valuation for Traditional Retail Insurance Replacement

Item 1

One, 3pce set, hand-assembled raised, 18ct yellow and white gold, gemset, multistone rings.

Plain, wide, low half round, tapered band, measure a combined basal width 6.73mm x 0.80mm depth, with curved underrails.

Feature; "3pce ring set". Comprising, a solitaire style ring to centre, two outer single row style bands. Housing one pear-shaped, faceted diamond claw set white gold, The extended shoulders, of the yekllow gold band, tapers up, split to each side, with pointed end terminatins. The single row bands, each side containsfive round brilliant cut diamonds, channel set, both sides



Polished finish, stamped "18ct" - acid tested as 18 carat gold. Finger size = L1/2.

The ring set contains;

One claw set pear-shaped, faceted, diamond, colour is "G", medium cut quality.

Dimensions = 5.81mm (L) x 4.01mm (W) x 2.45mm (D-estimated)

Total Weight = 0.34ct (estimated - see NOTE below).

Ten channel set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 3.20mm (average diameter) x 1.95mm (D-estimated)

Total Weight = 1.22ct (estimated - see NOTE below).

Total Item Weight = 9.01 grams, Total Gemstone Weight = 1.56ct, Total Metal Weight = 8.70 grams (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar 3pee ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
