One, lady's hand-assembled raised, 18ct yellow and white gold, diamond set, solitaire ring.

Plain, wide, half round, tapered band, measures 3.22mm width (at base) x 1.28mm depth, with curved underrail.

Feature, solitaire style" ring design. Comprising, a raised six claw, white gold setting, houses one round brilliant cut diamond (laser inscribed), claw set. The extended shoulders, of the yellow gold band, tapers up to a pyramid profile termination, to both sides.

Polished finish, stamped "750, RAND 0.40" - acid tested as 18 carat gold.

Finger size = N.

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.
Dimensions = 4.85mm - 4.83mm (average diameter) x 2.92mm (D-estimated)
Total Weight = 0.40ct (known weight - see NOTE below).

Total Item Weight = 4.07 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 3.99 grams (estimated)

The diamond has also been laser inscribed upon the girdle with GIA (logo) 13132358 & RSA 308D22MM.
