Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand assembled, 18ct yellow gold, solitaire style, ring set, of cast construction.

The set comprising a 18ct yellow gold diamond set engagement ring with a fitted and matching 18ct yellow gold wedding ring. Each ring having a plain, narrow, low half round, tapered band with a combined basal width of 4.31mm x 1.49mm in depth.

The engagement ring has a central bezel setting, housing one round brilliant cut diamond, bezel set. The setting is secured between the shoulders of the plain and polished band.

The fitted and matching wedding ring, has a curve in the centre, is a plain and polished band. The wedding ring sits alongside the engagement ring above.

Polished finish. Stamped '750' - acid tested as 18 carat gold. Ring size: N 1/2.

The ring set contains:

- One bezel set round brilliant cut diamond, clarity is "P2", colour is "G".
- Dimensions = 5.06mm(L) x 5.03mm(W) x 3.23mm(D-estimated) x 2%(Girdle Thickness)
- Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 6.17 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 6.07 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
